1) Scóip na scéime/ Scope of the scheme

- iii. Droichid bheaga

Chomh maith leis an méid sin, is féidir obair a dhéanamh freisin ar Bhóithre Conláiste. Is bóthar neamhphoiblí an Bóthar Conláiste a théann chomh fada le háiseanna nó saoráidí tábhachtacha de chuid an phobail, mar shampla, reilig, trá, cé, bealach suas ar shliabh nó láthair eile turasóireachta/oidhreachta.

The local improvements scheme applies only to works for the joint benefit of groups of one or more farmers, (and or) on the following kinds of non-public roads:

- i. Accommodation works to houses, farms and bogs
- ii. Roads used by the public or which connect two public roads
- iii. Small bridges

In addition, works can also be carried out on Amenity Roads. Amenity Roads are non-public roads leading to important community amenities such as graveyards, beaches, piers, mountain access points or other tourist/ heritage sites.

- iv. Tionscadail bhóthair a thugann rochtain ar phíosaí talún a bhfuil ceann acu faoi úinéireacht nó in úsáid ag duine atá ag gabháil do ghníomhaíochtaí talmhaíochta AGUS a fheidhmíonn mar bhóthar conláiste.

Ba cheart d'iarratasóirí ábhar cáipéisíochta a chur ar fáil lena ndeimhnítear go bhfuil siad i mbun gnóthaí talmhaíochta ar ghabháltas talún a ndéantar bealach chuige ar bhóthar an tionscadail e.g. uimhirtréada agus cóip de na mapaí a ghabhann leis an iarratas a rinneadh faoin Scéim Hílocaíochta Bunúsaí arna riad ag an Roinn Talmhaíochta, Bia agus Mara, nó cáipéisíocht eile ar aon dul leis sin. Eligible road projects are those that involve the construction or improvement of non-public roads as follows:

- i. Road projects which provide access to parcels of land of which one or more are owned or occupied by different persons engaged in separate agricultural activities; or

- ii. Road projects which provide access for harvesting purposes (including turf or seaweed) for two or more persons; or
- iii. Road projects which provide access to at least one parcel of land owned or occupied by a person engaged in agricultural activities AND which separately provide access for harvesting purposes (including turf or seaweed) for at least one other person; or
- iv. Road projects which provide access to parcels of land of which one is owned or occupied by a person engaging in agricultural activities AND which serves as an amenity road.

Applicants should provide documentation to verify that they are engaged in agricultural activities on the parcel of land accessed by the road project e.g. a herd/flock number and a copy of the maps associated with their Basic Payment Scheme application provided by the Department of Agriculture, Food and the Marine, or equivalent documentation.

- ii. The works must be strictly necessary and not merely ordinary maintenance or of a kind which the applicants could reasonably be expected to do themselves
- iii. Drainage works on their own will not be eligible under the Local Improvement Scheme.
- iv. Roads where LIS works are completed will not subsequently be taken in charge by Galway County Council.

The correct name(s) of the townland(s) where the works are to be done must be stated and also where the proposed works begin and end, by the inclusion of start and finish coordinates and by referring to local landmarks or to houses or farms. If a road branches off an existing public road,

state in what direction it leads, i.e. north, south, east, or west. The following are examples of the kind of description required:

Local Improvements Scheme 2025 - Terms and Conditions

The Local Improvements Scheme applies to works to support the improvement of non-public roads and laneways that are not normally maintained by Local Authorities. These roads could be bog roads, roads which connect two public roads and small bridges. In addition, works can also be carried out on Amenity Roads. Amenity Roads are non-public roads leading to important community amenities such as graveyards, beaches, piers, mountain access points or other tourist/ heritage sites.

- 1) A local contribution of 10% is required for eligible roads with up to and including five residents. A local contribution of 15% is required for eligible roads with six or more residents. In addition, the maximum amount that any individual household/landowner will be asked to contribute is being capped at €1,200 under the 2025 LIS.
- 2) The works must be for the joint benefit of one or more adjoining farms, and the benefit to be derived must be reasonably commensurate with the cost.
- 3) The work must be strictly necessary and not merely ordinary maintenance or of a kind which the applicants could reasonably be expected to do for themselves.
- 4) The applicants must make the necessary apportionment amongst themselves of their respective portions of the joint contribution and must arrange to collect the agreed amount and lodge it with Galway County Council before the work is put in hand.
- 5) The contributors and any other persons whose lands or interests appear to be affected by the proposed works must, when required prior to the commencement of operations, sign the prescribed form giving their full consent to the execution of the works including entry to their lands.
- 6) Contributions in kind e.g., free labour or materials, will not be accepted in lieu of cash.
- 7) The applicants must arrange amongst themselves for the provision without cost to Galway County Council of any lands which may be required for the construction or widening of the roadway or drain as the case may be.
- 8) Galway County Council will employ the necessary labour and will arrange to carry out the works.
- 9) Galway County Council, in their discretion, will decide on the specification of the works to be done and on the best manner of carrying them out, and the applicants shall not have any claim against the Council for any imperfection which may exist in the finished works, nor for any failure to complete the full amount of the works which were envisaged.

10) Galway County Council will expend on the works the sum agreed upon (i.e. the estimated cost) and in the event of that sum not being sufficient to complete the entire works specified, the County Council will not have any liability to be bound to expend on the works for their completion any sum in addition to the agreed sum. The making of a supplementary grant will be considered on its merits if the applicants so request and agree to pay such sum as may be required by way of additional local contribution.

11) Proposed works in designated areas, such as Special Areas of Conservation (SAC), Special Protection Areas (SPA), etc. - any necessary screening for appropriate assessments and/or other ecological assessments/approvals/planning permission/Part 8 planning consent etc. that need to be obtained must be in place prior to any works commencing.

12) When the works have been carried out, the applicants shall maintain it in good order and repair at their own charge and expense and Galway County Council will not have any liability for the maintenance of the works.

13) There is no obligation on Galway County Council to take in charge a road on which works have been carried out und the Local Improvement Scheme.

An Scéim Feabhsúcháin Áitiúil 2025 - Téarmaí agus Coinníollacha

Baineann an Scéim Feabhsúcháin Áitiúil le hobair ar mhaithe le feabhas a chur ar bhóithre agus ar lánaí neamhphoiblí nach iondúil gur Údarás Áitiúil a dhéanann obair chothabhála ina leith. - 5) Ní mór do gach duine de na ranníocóirí, agus d'aon duine eile a gcurfeadh, de réir cosúlachta, an obair bheartaithe isteach ar thailte ná leas eile dá gcuid, síniúchán a chur leis an bhfoirm shainordaithe, an tráth a n-iarrtar sin orthu roimh thosach na hoibre, ina dtugtar lánchead an obair a dhéanamh, lena n-áirítear dul isteach ar a gcuid tailte.
- 6) Ní ghlacfar le cúnamh comhchineáil e.g., saothar ná ábhar saor in aisce, seachas airgead.
- 7) Ní mór do na hiarratasóirí socrú a dhéanamh eatarthú féin maidir le talamh ar bith a d'fhéadfadh a bheith ag teastáil don obair thógála ná leathnúcháin ar bhóthar ná ar dhraein a chur ar fáil do Chomhairle Chontae na Gaillimhe gan chostas.
- 8) Fostóidh Comhairle Chontae na Gaillimhe oibreoirí de réir mar is gá agus is í an chomhairle a dhéanfaidh na socruithe do dhéanamh na hoibre.
