### SICAP

The contracts for SICAP 2024-2028 will be finalised in May with the programme commencing across 3 Lots – Galway East, Galway Islands, Galway West – from 1<sup>st</sup> June 2024. Training on the new SICAP Programme will be delivered to Programme Implementers by Pobal, following which LCDC approval will be required to revised Annual Plans 2024.

#### COMMUNITY RECOGNITION FUND 2024

The Community Recognition Fund 2024 is open for Expressions of Interest from locations which are hosting significant numbers of New Arrivals, and a briefing session has been held for Elected Members and PPN Members. Under the first application window, consideration will be given to proposals from the 4 areas hosting the highest level of New Arrivals, i.e., Clifden, Oranmore, Maam, and Letterfrack, and 3 Administrative Officers have been assigned across these areas to conduct site visits with potential applicants, and conduct comprehensive consultations with a range of stakeholders, as required under the Departmental Guidelines.

### SOCIAL INCLUSION

#### AGE FRIENDLY PROGRAMME

Staff from a range of departments of the Council visited Inis Oirr on 25<sup>th</sup> April to carry out an audit of social & leisure activities, with the aim of increasing opportunities for older people to engage in community, cultural and sporting activities. A site visit to Inis Meain is taking place on 16<sup>th</sup> May, with further visits to Inisbofin and Inis Mór to be finalised, following which further events are planned for Men's Health Week in June.

### COMMUNITY AWARDS

Preparations are being finalised for the Cathaoirleach's Gala Ball and Cathaoirleach's Awards to be held in the Clayton Hotel on 16<sup>th</sup> May at 6.30 p.m. Representatives from groups in a range of categories have been invited to the Ceremony to honour their achievements, and further information will be provided in the June Management Report.

### AFRICA DAY 2024

Preparations are being finalised for Africa Day 2024 which will be celebrated in Tuam with a series of events culminating to an all-day festival of events on 25<sup>th</sup> May which is the designated Africa Day in 2024.

### PUBLIC PARTICIPATION NETWORK (PPN)

Galway County Public Participation Network continues to grow its membership and during May, facilitated information and invitations to the AIB Community Fund and the CLAR and Community Recognition Fund information sessions. The PPN are also involved in the planning of the Cathaoirleach's Awards, events for Men's Health Week, and a summer Plenary Meeting.

### LOCAL ECONOMIC & COMMUNITY PLAN

Request for quotation exercise just before Christmas to develop a framework Local Economic and Community Plan (LECP) and an initial two year Implementation Plan for County Galway. Hub Planning appointed early in the new year. ASG recommended the socio economic statement for approval to both the Economic SPC and LCDC. Both committees approved these



documents. Hub Planning have merged both documents, added in some packaging and branding. The public consultation element will commence in the third week of May. As part of this in June there will be a walk-in event at one location in each of the five MDs with separate on street engagement in separate locations within each MD. The anticipation is the LECP will go before plenary Council for adoption in the Autumn of 2024.

### COMMUNITY RECOGNITION FUND

The Community Recognition Fund 2024 (GCC received €1,303,230) aims to support the development of community infrastructure and facilities for the entire community in recognition of the contribution being made by communities across the country in welcoming and hosting significant numbers of arrivals from Ukraine and other countries. Projects situated in areas that do not currently have high levels of New Arrivals cannot be deemed eligible, therefore, Galway County Council has collated the list of towns/villages which are eligible at this time, by virtue of hosting significant numbers of New Arrivals.



### TINY MUTINY OPEN CALL

Tiny Mutiny offers creative teenagers the opportunity to realise their artistic ideas with support from a professional mentor along with a production budget. Teenagers can apply with an idea focusing on creative practices like theatre, visual art, dance, film, circus, writing, digital media, graffiti, music etc.

The selected young artists will be given a professional artist mentor, a budget and practical support from Sparkcatchers! from June to October 2024. At the end, there will be a showcase at an arts event for children and young people in October.



Sparkcatchers! are Jojo Hynes & Midie Corcoran; artists, producers, festival makers and disruptors that work with young people to make brilliant art. This call out is a follow up to a



project called <u>Tiny Mutiny</u> and inspired by a project in The Netherlands called <u>Broei</u>.

The closing date for applications is midnight on 14<sup>th</sup> June. 'Ideas and Information' workshops for interested 13–17-year-olds will be in Tuam, Gort, Ballinasloe and Oughterard.

### CREATIVE IRELAND

### CRUINNIÚ NA NÓG – NATIONAL DAY OF CREATIVITY FOR CHILDREN – JUNE 15<sup>TH</sup>

It's been a busy month for Creative Ireland. With preparations for Cruinniú na nÓg 2024 well and truly underway, the team have been working hard to get as many free events as possible taking place for children across the county.



This year there has been a focus on increasing Cruinniú na nÓg engagement on the Aran Islands. A youth consultation was carried out on the islands by Branar theatre company. The report from this was used to plan and budget a programme of events on the island. An additional €7,000 of funding was secured to deliver this programme which looks to be an engaging and exciting day for the children on the islands. All of the workshops will be delivered through Irish. The programme so far features drumming, gardening, music, painting, coding, and mosaic work with more to be added in the coming weeks.

There is also a push to increase engagement with older teens. With this in mind, Creative Ireland have introduced Cruinniú Late, an initiative whereby events will be specially programmed for 16–18-year-olds and held later in the evening. An additional €4,000 of funding was secured from the Nighttime Economy Officer of Creative Ireland to support this. Galway County Council's Cruinniú Late event is being managed by Gliondar Creative Arts and will consist of a 1-day Youth Festival held in Athenry on the night of June 15<sup>th</sup>. The celebrations will include stilting, circus skills, and a live gig from youth band Moonlight Eclipse with more details coming soon.

In total so far 55 events have been registered for Cruinniú na nÓg up from 29 last year, and 49% incorporate the Irish language up from 20% in 2023. All in all it's looking like it's going to be a great day. For details on Cruinniú na nÓg events taking place in your area check <u>here</u>.

### CREATIVE IRELAND BURSARIES

Many of the Creative Ireland Bursary projects are underway. We have seen great interest in

these projects which cover music, ceramics, and circus skills. With 5 months left to complete the bursaries, it's very exciting to see what will come next from our Creative Communities.

Athenry Music School have started their 'Samba le Chéile' drumming workshops. These are open to all levels of ability and will be ongoing until October.



**Brú Bhríde** are continuing their highly successful programme of Circus Skills training. This programme is specifically run for children from the Travelling Community in Tuam. Last year's participants reported a rise in confidence and self-esteem after taking part in the programme. The 2024 workshops began in March and will run until early June.



**Cois Cladaigh Centre Art Group**, a BOCSI group based in Casla, have begun their 2024 Creative Ireland project. 'Aistear an tSaoil' is a ceramics workshop where participants will create boats to reflect the history of fishing in their homeplace. This is a follow-on from their 2023 project which consisted of selfportraits that examined the participants' place within their community.

### FUSE Music Collective are seeking

participants for their 'Half-Speed Trad' sessions. The ideal outlet for anyone who has ever wanted to give Traditional Music and Sean Nós singing a go but felt it was all just a bit too fast for them. The sessions are led by Tuam Comhaltas and will take place from 8-9pm at The Mall Theatre, Tuam on May 30<sup>th</sup>, June 27<sup>th</sup>, July 25<sup>th</sup>, August 29<sup>th</sup>, and September 19<sup>th</sup>.

### HEALTHY IRELAND OUTDOOR SWIMMING INFRASTRUCTURE SCHEME

Galway Sports Partnership attended the launch of Healthy Irelands Outdoor Swimming Infrastructure Grant, which was launched in Renville, Oranmore by Minister Hildergarde Naughton on 4<sup>th</sup> April. Local Authorities through the Local Sports Partnership can apply for funding up to €30,000 towards projects that enable broader participation in outdoor swimming, such as improving access, developing, and enhancing changing facilities and procuring equipment to assist people with disabilities.

### PARTICIPATION NATION OUTDOOR FUND

The Minister of State for Sport, Physical Education and the Gaeltacht, Thomas Byrne T.D., has launched a new sport investment fund, the 'Participation Nation Outdoor Fund', for the purchase and installation of permanent sport equipment that can be placed on public land for community use.

Local Sports Partnerships will apply for the fund as the representative body and the project will be delivered in collaboration with Local Authorities, Climate Action Officers and/or the National Governing Bodies for Sport.



In respect of the Local Sports Partnerships, it is proposed that applications will be a minimum of €100,000, which will focus on the purchase of low-cost permanent sport equipment and to cover the costs of biodiversity measures. Given the significantly higher cost of installation of outdoor sport equipment compared to biodiversity measures, it is proposed that the funds be broadly allocated on a 3:1 basis; it is therefore expected that in the order of €30,000 of the allocated amount will be provided to biodiversity measures.

The list below, which is indicative and not exhaustive, sets out sports/means of physical activity which are considered amenable to fulfilling the purpose of the fund:

- Installation of sport equipment lockers.
- Storage containers for water sports such as kayaking, canoeing.
- Croquet, boules, table tennis tables.
- 3x3 basketball courts.
- Multi-use projects e.g., aerial activity with mountain biking courses.
- Permanent volleyball nets; and
- Golf (putting greens).

The list below, which is indicative and not exhaustive, sets out biodiversity measures which are considered

to fulfil the purpose of the fund:

- Installation of bat/bird/owl boxes and/or beehives.
- Native hedgerow and grass verge management.
- Installation of ponds.
- Planting of native flora species, pollinator habitats and/or mini/pocket forests.

### Closing date for applications is Friday, 21st June 2024 at 12pm.

### CLUB DEVELOPMENT GRANT

Galway Sports Partnership through funding from Sport Ireland ran a Club Development Grant Scheme worth €30,000. The Club Development Scheme is designed to support your clubs or sporting organisation to expand and develop in the areas that support our main target groups getting active and getting introduced to the club for future membership.

These main targets include women & girls, older adults, unemployed individuals, individuals from disadvantaged areas, individuals with disabilities, young people & ethnic minorities.

28 Clubs and Organisations across Galway were successful with their applications.

### **RURAL SCHEMES**

#### TOWN AND VILLAGE RENEWAL SCHEME



In April 2024, the communities of Gort, Dunmore and Maree have received a major funding boost after Minister for Rural and Community Development, Heather Humphreys T.D. announced an allocation of €750,000 to Galway County Council under the Town

and Village Renewal Scheme 2023.

A grant 250k has been approved for the renovation and improved Accessibility of Dunmore Community Centre which will be implemented in partnership with Dunmore Community Council. Traditionally referred to as the Town Hall, the space on The Green remains essential to the social and cultural vibrancy of Dunmore.

Maree Community Centre has been awarded 250k to understand essential repairs to ensure the continuation of community activities at the Centre. The Groups will have until August 2026 to complete proposed works and draw-down Grants.

Furthermore, an allocation of €250,000 has been granted to for implementation of a Streetscape Enhancement Scheme for Gort Town Centre. The Gort scheme allocation has been warmly welcomed by the local community and follows an application by the Gort Town Team with the support of Galway County Council's Town Regeneration Officer. This Scheme Gort and will allow individual property owners and tenants in the designated streets to submit an application for funding of up to 80% of the costs to a maximum amount per property, towards the enhancement of their façade, including painting, appropriate lighting and decluttering. The Guidelines are being finalised which will state the amounts, type of works. Galway County Council Rural Schemes Team and Regeneration Team have supported similar Schemes in 10 locations across the County since 2020. The engagement by Galway County Council of a colour consultant to provide recommendations on

paintcolour schemes for properties owners has added value to the quality and outputs of the Scheme and can assist in motivating shop keepers / property owners to take part.

### RURAL SCHEMES - CLÁR 2024 PROGRAMME

Applications are now sought for the CLÁR 2024 Scheme which can be submitted to Galway County Council up to May 31<sup>st</sup>, 2024. Open to designated CLÁR areas, the maximum grant is €50,000 at 90% of Eligible Costs for small scale infrastructural projects. The 2024 programme will be delivered through 3 separate Measures as follows:

- Measure 1: Developing Community Facilities & Amenities
- Measure 2: Mobility, Cancer Care, Community First Responder and Meals on Wheels Transport
- Measure 3: 'Our Islands'

Measure 1 will support a variety of capital projects provided that they contribute to the enhancement of existing, and/or the development of new, accessible Community Recreation Facilities. The list below provides an indication of the types of projects that may be supported, but is not exhaustive:

- Small scale renovation works to community facilities open to the wider community such as community centres/sports centres/clubhouses of sporting groups/youth centres/mens sheds
- Multi-Use Gaming Areas (MUGAs)/Astro-Turf facilities including upgrades
- Playgrounds/Skateboard parks/Pump tracks/Cycling tracks

- Walking/Running /Athletics tracks
- Handball Alleys/Tennis Courts/Basketball Courts/Cricket Grounds
- Community Gyms/Community Cinemas
- Sensory Gardens/Community Gardens/Allotments
- Access to unique local heritage sites/areas of natural beauty
- Outdoor Bowling Areas/Outdoor Toilet Facilities/Car Parking
- Improving access at sports grounds e.g. development/upgrade of spectator stands at local sports grounds with a particular focus on improving access for people of all abilities and ages
- Solar Bins
- Biodiversity planting

Fully completed forms for **Measure 1** must be returned to Galway County Council by **5:00 pm on Friday 31st May 2024** via <u>https://galwaycoco.submit.com</u>. A maximum of 15 projects will then be shortlisted and developed into a final submission to Department of Community and Rural Development.

Applications for Measures 2 and 3 must be made directly to the Dept. of Rural and Community Development and cannot be accepted by Galway County Council.

Any facilities funded must be available to the public without a requirement to be a member of a club, enrolled in a school etc. Facilities on school grounds must be open to the public outside of school hours e.g., during the evenings, weekends, and school holidays.

### EU JUST TRANSITION FUND ACTIVATOR FOR THE BALLINASLOE MD

Loretta Raftery has been appointed EU Just Transition Fund (EU JTF) Tourism Activator for



County Galway. Ms. Raftery, has over 20 years of local authority experience in the fields of tourism, community, and economic development.

The Ballinasloe MD is included in the EU JTF territory and SMEs in the region can avail of Fáilte Ireland's Regenerative Tourism and Placemaking Scheme for Ireland's Midlands 2023-2026, which is being co-funded by the Government under the EU JTF. The programme is investing in projects that promote the sustainable development of tourism in the region with the aim of diversifying the regional economy by creating jobs, supporting habitats and biodiversity and sustaining communities.

A series of public information evenings will take place in Ballinasloe and Glenamaddy next week.

Local community groups and tourism SMEs are invited to attend the upcoming information evenings on Wednesday, May 8th, from 6.30 to 8.30pm in the Shearwater, Ballinasloe and on Friday, May 10<sup>th</sup> from 6.30 to 8.30pm in Glenamaddy, The Old Technical School.

Eligible projects under the Regenerative Tourism and Placemaking Scheme currently fall into four categories, namely Development or Enhancement of Sustainable Visitor Experiences, Development of Sustainable/Low Carbon Tourist Accommodation, Capital Project Planning & Design and Accessibility enhancements to provide a more inclusive visitor experience.

The deadline for expressions of interest is 30<sup>th</sup> June next and once deemed eligible, groups will have the opportunity to make an application to the fund up to 30<sup>th</sup> December 2024.

### NEW NATIONAL TOURISM OFFICER NETWORK



The Tourism Officer Network was officially established during an inaugural meeting on April 19, 2024, at Killashee Hotel in Naas, Co. Kildare, with representatives from every county in Ireland. This network is designed to enhance collaboration across County Council Managed Authorities (CCMA) to promote tourism and

drive economic growth. The network will provide a platform for sharing best practices, coordinating tourism-related initiatives, and supporting sustainable tourism development across the regions. With structured meetings set to occur three times annually, the network aims to significantly impact the effectiveness of tourism activities managed by local authorities.

GCC Tourism Officer John Neary was elected as the Deputy Chair of the Tourism Officer Network for a 3-year term.



### INTERNATIONAL NETWORK OF SUSTAINABLE TOURISM OBSERVATORIES




The project at Atlantic Technological University (ATU) represents the establishment of Ireland's first International Network of Sustainable Tourism Observatories (INSTO), . By gathering data and insights on tourism's impacts, the observatory seeks to inform and shape policies that foster environmental, social, and economic sustainability in tourism.





#### April's Top Three Posts





### LIBRARY SERVICES

Galway Public Libraries is 100 years old this year. Our first public Centenary celebration took place on April 23 in Rahoon Cemetry with a graveside commemoration and wreath laying ceremony to honour Galway Public Libraries' first librarian, Samuel James Maguire, who established, developed, and managed the county's public library service for 31 years, from 1924 to 1955. In attendance was the Mayor of Galway City Cllr. Eddie Hoare, the Cathaoirleach of the County Cllr. Liam Carroll, members of Samuel's family, former County Librarians and current library and archives staff.

Our MC for the event, Galway County Council Archivist, Patria McWalter welcomed all to the very special event, which she said, 'marked not only the centenary of Galway Public Libraries, but most especially honours its first librarian, Samuel – better known as Sam – James Maguire'.

Samuel Maguire began work in Galway in 1924 on behalf of the Carnegie Trust and was appointed County Librarian in 1926 when Galway County Council assumed control of the service. During his tenure Maguire managed over 300 book lending centres and branch libraries in Abbeyknockmoy, Athenry, Ballinalsoe, Ballygar, An Cheathrú Rua, Clifden, Dunmore, Glenamaddy, Headford, Killimore, Loughrea, Moylough, Oughterard, Portumna, An Spidéal, Tuam and Woodford – most of which were open 10-hours a week.

The legacy of Samuel Maguire lives on in a vibrant library service with 29 branches across the County of Galway including 4 which are offshore on the Aran islands and Inisbofin. It has adapted and evolved to meet the changing needs of Galway communities.

Galway Public Libraries is indebted to Cllrs. Carroll and Hoare, County Librarians Jo Vahey, and Pat McMahon, Galway County Council Archivist Patria McWalter and Fergal Pettigrew (grandson) who all spoke so movingly about Samuel J. Maguire.

## VACANT HOMES



Further to information events held throughout the County in previous weeks, the Vacant Homes Unit attended an information evening in the Clifden Station House Hotel on the 22nd April, to give information on the Vacant Property Refurbishment Grant, the Local

Authority Home Loan scheme, the Disabled Persons grant, the Housing Aid for Older Persons, and the Mobility Aids grants. The event was hosted by Connemara Chamber of Commerce in conjunction with Galway County Council, Sustainable Energy Authority of Ireland (SEAI) and the Local Enterprise Office (LEO). Information on Business, Energy and Housing supports were provided on the night.

#### VACANT HOMES ACTION PLAN

The Elected Members of Galway County Council have approved a five-year plan by the Local Authority to tackle vacancy rates and increase new housing supply.



The Vacant Homes Action Plan 2024-2029 features seven key objectives that include bringing vacant and underutilised privately-owned properties back into use and acquiring derelict and vacant brown field sites to convert into residential units to meet social housing demand in key county towns.



The residential vacancy rate in Ireland's second largest county was the third highest in the country in June 2023 at 6.0%, compared to the national average of 3.9%.

"Galway County has a high demand for housing across all tenures, which is exacerbated by a growing population and wider issues around the affordability and availability of rental and purchase properties," commented **Clir. Liam Carroll, Cathaoirleach of Galway County Council**.

He continued, "The Elected Members fully support the objectives of this high-level strategy document in addressing vacancy and underutilisation of residential properties, thereby increasing the supply of housing in the county."

Liam Conneally, Chief Executive of Galway County Council said the new plan looks at why private properties become vacant, what advice and assistance is available to the owners of vacant properties, and how Galway County Council uses the range of available schemes and supports to support owners and prospective owners of vacant properties to return the properties to use.

He added, "This action plan aims to provide a targeted approach to identifying vacant housing units with the intention of bringing these properties back into use for both private and social housing. The plan also seeks to promote the development of town and village centres, which can help reduce dereliction and vacancy."

Galway County Council has committed to implementing a series of targeted actions in the lifetime of the plan including establishing and maintaining a database of vacant properties, reintroducing the Choice Based Letting (CBL) scheme for houses in hard to let locations, and the compulsory purchase of buildings under the Derelict Sites Act and the disposal of derelict social houses that are no longer viable so that they can be brought back into use as private or social housing.

Other actions include working with owners of vacant properties identified in a Vacant Homes Survey conducted by the Local Authority in 2023 with a view to bringing vacant properties back into use, minimising the vacancy level of unfinished housing estates, and increasing participation in the Vacant Property Refurbishment Grants (Croí Cónaithe Scheme), which attracted 364 applications up to the end of the first quarter of 2024.

The Local Authority also has appointed a full-time Vacant Homes Officer to co-ordinate the roll-out of the new plan. Their role includes collecting and monitoring vacancy data and increasing uptake within the local community of various initiatives, schemes, and funding programmes to address vacancy and bring vacant properties back into residential use.

**Michael Owens, Director of Services, Housing & Ukrainian Response**, said the shortage of housing within the county is affected by the number of applicants (3300) on Galway County Council's social housing list, an increase in housing support applications being received by the Local Authority, a rental market where demand exceeds supply, and people and families remaining in either rental accommodation or private accommodation that is unsuitable for their needs.

"The provision of housing for those who are unable to do so for themselves is a high priority and a major challenge for Galway County Council," he added. "The aim is for every household that has a need to be able to access a quality and affordable home that is suited to their needs and is in a secure environment. Bringing



vacant homes back into use will assist us in achieving this objective."

Mr. Owens confirmed that Galway County Council is in consultation with the Department of Housing, Local Government and Heritage to set an annual target for the number of vacant properties to be activated during the lifetime of the new plan.






"This target will include the number of vacant properties to be subject to CPO by Galway County Council, if necessary, to bring them back into use. It is envisaged the target for activation will be several hundred per year," he concluded. Prepared by the Housing Department of Galway

County Council under the auspices of Pathway 4 of the

Government's Housing for All programme, the Vacant Homes Action Plan 2024-2029 has featured input from the Local Authority's Planning & Economic Development and Rural & Community Development departments in relation to the activation of vacant properties in the Town & Village Renewal Scheme as well as key criteria in the Urban Regeneration & Development Fund (URDF), Rural Regeneration & Development Fund (RRDF) and the Town Centre First Policy.

# VACANCY/DERELICTION ACTIVATION PROGRAMME

Targets to activate vacant properties will be set annually for Galway County Council by The Department of Housing, Local Government and Heritage. Under this Programme, Galway County Council is now required to adopt a proactive, planned, and systematic approach to the identification and activation of vacant and derelict properties. 138 properties have now entered the Vacancy/Dereliction Activation Programme, these 138 properties are properties which have been approved for the Vacant Property Refurbishment Grant. Three properties have exited the Programme as the properties have been brought back into use, following payments of the Vacant Property Refurbishment Grants.



#### HOUSING MAINTENANCE

The Galway County Council Housing Unit has a dedicated Housing Maintenance team that deal with reactive maintenance requests received from tenants. There are currently three crews based in Ballinasloe, Sandy Rd. and Tuam. Tenants can log their repair requests anytime of the day via an online application. In Q1 2024 the council received 1,234 repair requests, of these 701 were deemed invalid as repeat requests or requests relating to items of tenant responsibility, as per the tenant's Handbook. 533 were sanctioned for repair and 362 of these were closed out during that period. The nature of the request is categorized below. As can be seen from the chart below, the majority of repair requests relate to plumbing and heating at 48%. Electrical repair requests are greatly reduced as a result of the ongoing Planned Maintenance Programme where all houses over 10 years old are having a full electrical check and upgrade works where deemed necessary.

## DISABLED PERSONS GRANT SCHEME

Every year Galway County Council receive an allocation of funding from the Department of Housing, Local Government & Heritage under the Disabled Persons Grant Scheme. The purpose of the scheme is to provide funding to the council to carry out works to council owned housing stock to facilitate tenants with disabilities so that they can continue to live in their existing homes. For the 2024 scheme Galway County Council received an allocation of €676,898 from the Dept. In Q1 2024 the council received 16 applications for DPG works and these are currently being assessed. In addition, in Q1 the Housing Maintenance team carried out detailed design and tendering for works to 20 houses from existing applications. The successful contractor was recently appointed, and works have commenced. It is intended to carry out four extensions to existing houses to provide ground floor accommodation. These are currently at design and tender stages. A sample of the works can be seen in the photos below.

# NEW SOCIAL HOUSING DEVELOPMENT OFFICIALLY OPENED IN GLENAMADDY



22 New Social Homes at Lakeview, Glenamaddy A 22-home social housing scheme was officially opened in Glenamaddy, County Galway today (Wednesday, 8 May 2024) by Leas Chathaoirleach of the County of Galway, Cllr. Evelyn Francis Parsons and Cathaoirleach of the Ballinasloe Municipal District, Cllr. Declan Geraghty.

Supported by €6,118,074 in funding from the Department of Housing, Local Government and Heritage, the Lakeview development is the latest in a series of local authority led housing schemes taking place across County Galway.

The housing scheme was acquired by Galway County Council from Renaissance Property Ltd. as a turnkey development and is a continuation of an existing private estate of 20 detached and semi-detached homes.

The homes include 2 two-bed detached bungalows and 8 demi-detached three-bed, 4 semidetached four-bed, 4 end terrace 3-bed and 2 mid terrace two-bed town houses.

Cllr. Evelyn Francis Parsons said the delivery of the new homes marks the completion of the housing estate and greatly boosts existing social housing stock in the area.

"These modern and A-rated new homes will inject new life into Glenamaddy due to their location between Glenamaddy Community Centre and Glenamaddy GAA grounds and close proximity to the town centre and other sports and recreational facilities," he added. "The town also has a primary and secondary school, both located within walking distance to the Lakeview development, which makes it an ideal location for families to integrate into and become valuable members of their new community."

Cllr. Declan Geraghty said the new homes deliver much-needed social housing for the wider north Galway area.

"The Lakeview homes have incorporated the latest design and materials to ensure a high level of energy efficiency," he said. "The high standard of construction of these stylish and



energy efficient will support and enhance family life and ensure that they are future proofed for their occupants."

**Liam Conneally, Chief Executive of Galway County Council** commented "I wish to acknowledge the central role played by the Department in providing the necessary funding for this scheme and Renaissance Property Ltd. for their delivery of these high-quality homes. Galway County Council is firmly committed to delivering our targets under Housing For All and ensuring that the housing needs of all of County Galway are provided for."

**Michael Owens, Director of Housing with Galway County Council** said the recent adoption of the Galway County Council Vacant Homes Action Plan 2024-2029 underpins the local authority's commitment to increasing housing supply in the county.

Mr. Owens explained, "The opening of this new scheme is evidence of the progress being made across County Galway. There continues to be a shortage of housing within the county, but our planned programme of investment ensures that more and more of social housing list applicants will be accommodated in the coming months and years. In recent weeks, for example, we have announced the planned provision of 222 homes in seven new housing developments in Ardrahan, Athenry Ballinasloe, Loughrea, Portumna and Tuam."

PROPOSED DEMOLITION OF AN EXISTING DWELLING AND OUTBUILDING AND CONSTRUCTION OF 2 NO. 2 BED DWELLINGS @ BARKHILL, WOODFORD, CO. GALWAY UNDER PART 8

It is proposed to demolish an existing dwelling and outbuilding which are in a state of dereliction and to construct 2 no. 2-bedroom dwellings, together with connections to existing public services, including all other ancillary site works and services at Barkhill, Woodford, Co Galway. Planning permission is now sought under part 8 of the Planning and Development Act 2000.

The application site is located within the settlement of Woodford which is defined as a Rural Settlement in The GCDP 2022-2028. The design shall encompass the principles of Universal Design for homes in Ireland to cater to a wide variety of occupants. Roadside parking shall be provided as shown in the site layout drawing PL01 below.

The planning report provided by Consultants Jennings O'Donovan, states that "the planning application will not have any impact on the setting of any cultural heritage assets. There is one on monument of regional importance....which would have once acted as a communal water source and has since been removed."

A screening assessment for EIA was carried out by Doherty Environmental Consultants Ltd. in December 2022 and determined that *"it can be concluded by the Galway County Council* that the project is not likely, alone or in-combination with other plans or projects, to have a significant effect on any European Sites in view of their Conservation Objectives and on the basis of best scientific evidence and there is no reasonable scientific doubt as to that conclusion"

On 29<sup>th</sup> April 2024 a submission was made on the proposal by the Department of Housing, Local Government and Heritage in consideration of the existing vernacular building on site.



Galway County Council Planning Department have issued a request for further information on the proposed development as follows:

(a) The Local Authority shall seek the advice of a suitably qualified conservation architect/professional to consider the adaptive reuse of surviving vernacular structures on site.

(b) In the event a decision is made to proceed with demolition a measured and photographic survey of the interior and exterior of the building shall be carried out by a suitably qualified building surveyor.

Requests for quotations have been issued to a number of Conservation Architects with a return date of Thursday 9<sup>th</sup> May.




FIGURE 2 - BARKHILL, WOODFORD DEVELOPMENT - SITE LAYOUT PLAN – NTS

# INFRASTRUCTURE & OPERATIONS DIRECTORATE & FIRE & EMERGENCY MANAGEMENT

### SPEED LIMIT REVIEW

As a follow on to Action 6 of Ireland's Government Road Safety Strategy (2021 – 2030) – *Our Journey Towards Vision Zero*, a working group was established to examine and review the framework for the setting of speed limits on Irish roads. The report "Speed Limit Review", with recommendations, arising from this review was published in September 2023.

The report contained principal recommendations relating to three different road categories:

- Recommendation that a default speed limit of 30km/h for **built up and urban** areas be introduced.
- Recommendation that the default Speed Limit on **National Secondary Roads** be reduced from 100 km/h to 80 km/h to align with the Safe System principles and to reduce the severity of head on collisions.
- Recommendation the default Speed Limit on **Local Roads** be reduced from 80 km/h to 60 km/h to align with the use of the network and the Safe System principles.

These priority actions are being progressed through necessary legislation and supporting Statutory Guidelines. The legislation became law on 17th April 2024 (Act Number 10 of 2024). Following the enactment of the legislation relevant Sections relating to Speed Limits will be commenced. Updates to the Statutory Guidelines for Managing Speed Limits will issue to local authorities by way of a Direction.

The Department of Transport have indicated an intention to work to implement the changes to a timeline that will see commencement dates for the new default speed limits as follows:

- End of November 2024 for Rural Local Roads.
- First half of 2025 for National Secondary Roads and Urban Speed Limits.

Galway County Council have developed a plan to ensure that all required changes can be made to meet the projected timeline. The first step involves an assessment of all local roads (total length 5,315km) that will default to 60kph, to ascertain if there are sections where



retention of the existing 80kph speed limit might be more appropriate. Such changes would be made by way of Special Speed Limit Bye Law, in accordance with the Road Traffic Act, where the change was consistent with the "Guidelines for Setting and Managing Speed Limits in Ireland".

A high-level desktop assessment of the local roads has shown that there may be up to 235km to 400km of local roads that may be suitable for an 80kph speed limit, based on criteria set down by the Department of Transport. This was also considered a the Transport SPC meeting on the 26<sup>th</sup> April, and members having been asked to consider the matter, agreed that should roads meet the criteria - having a road width of greater than 5.5m and centre road markings - that they then should be considered and assessed under the Guidelines for Managing Speed Limits to determine if they are appropriate for a special speed limit of 80kph. That assessment is now being undertaken.

On completion of the assessment, the recommendation arising will be brought before Municipal Districts for the consideration of the Members. Thereafter, the prescribed process for the approval of Special Speed Limit Bye Laws, including Public Consultation, will be followed. Bye Law approval will need to be in place ahead of the commencement of the new default 60kph speed limit for local roads, this coming November.

A very significant signage programme will be required to mount/erect all the additional and changed signs required as a result of the 2023 Speed Limit Review. The DoT will centrally purchase all the signage required on behalf of Local Authorities. Galway County Council will work with the Department to ensure accurate information gathering and the subsequent supply of appropriate numbers and types of signs and poles.

In summary, by the end of November 2024, the default speed limit on local roads will change to 60kph. For any sections of road where a speed limit higher or lower that this default has been assessed as appropriate, a Special Speed Limit Bye Law to that effect will have to be in place by that commencement date. All changes to signage to give effect to the changes will also have to be implemented at that time.



# GALWAY TO ATHLONE CYCLEWAY

Westmeath County Council and Galway County Council have developed a plan to deliver the next phases of the project and bring a development consent application to An Bord Pleanála. Due to its scale and complexity, the Galway to Athlone Cycleway Scheme will now be delivered as two separate schemes:

- Scheme 1 Galway to Portumna 114km in length: This scheme extends from Ballyloughane in Galway to the existing Waterways Ireland Greenway at Portumna Castle.
- Scheme 2 Portumna to Athlone 83 km in length: The scheme extends from the existing Waterways Ireland Greenway at Portumna Marina to Athlone Castle and includes a link to Ballinasloe.

Scheme 1 will be managed by Galway County Council and Scheme 2 will be managed by Westmeath County Council. A framework competition to procure new suitably qualified consultants to deliver the schemes was published on eTenders on the 2nd April 2024 and it is anticipated that the framework will be in place in June 2024.

## TII NATIONAL ROADS PAVEMENT SCHEMES

Transport Infrastructure Ireland have written to Galway County Council to advise that they are currently undertaking a review of their overall budget available for 2024 against planned expenditure. We have been instructed to pause the following projects once designs and tender documents have been completed and not to proceed to tender.

- N83 Baile Chláir Pavement Scheme
- N84 Bunnaconeen to Shrule Pavement Scheme

We have not been given a timeline for the review and as to what the outcome will be, however we will raise it at our monthly meeting with TII next week.

### ROADS UPDATE

#### LIS SCHEME

On the 23rd April 2024, Minister Heather Humphreys announced allocations for the LIS scheme for 2024 and 2025.

Additionally, the criteria was amended to now require only 1 no. herd number.

The two-year allocation for Galway County is €3,088,444. This is the largest allocation in the country.



Funding for 2024 and 2025 is per table below.

The Department has advised that the list for 2024 must be submitted by 24th May. This short timeframe will not facilitate the reopening of the scheme and assessment of new applications for submission to the Department for the current years work programme. Therefore, the Council will utilise the existing list for the 2024 works programme. For the 2025 programme of works please note that the scheme will reopen for applications per the table below.

A revised form will be available to Councillors and the public on 31st May 2024.

In relation to approved schemes on the existing list, where works have not yet commenced, these will be retained. There is no need for these applicants to re-apply. However, if a scheme was rejected previously for not meeting the requirement of two herd numbers, those applicants will need to re-apply.

# ISLANDS COMMITTEE MEETING

The Islands Committee consists of the three Aran Islands and Inishbofin Island and meets four times a year to address issues of concern on the four islands, e.g., piers; roads; planning; sewerage; housing; water supply; public toilets; burial grounds; fire service; coastal erosion; recycling centre; bins; signage, etc.

The Committee members are two representatives from each of the four islands, 9 Conamara Councillors, Director of Services Infrastructure & Operations Unit, two Roads



Senior Engineers, Conamara Area Office technical staff and meetings are co-ordinated by Deirdre Caulfield, Staff Officer.

The Committee plays a vital role by liaising with the four islands on a regular basis and giving assistance and guidance with projects and funding.

## **HEALTH & SAFETY**

## SAFETY REPRESENTATIVES 2024-2026

The safety representatives committee for the term 2024-2026 has been formed. 16 safety reps in total are on the committee, the current safety representatives are from a variety of different sections across the organisation.

Safety rep training was rolled out from March 19th to March 21st, 2024.

#### FIRE & EMERGENCY MANAGEMENT

### OPERATIONS

The information below is based on April data from West Regional Control Centre (WRCC). Galway Fire and Rescue Service (GFRS) had 142 turnouts to 119 Incidents. That is an increase of 4 incident on 115 the previous month. 52 were fire incidents, 65 were special service incidents (road traffic collision (RTC), Automatic Fire Alarms (AFA's), flooding, storm damage, etc.) and 2 were standbys either in station or at a central location. Of those incidents, 42.61% were attended by Fire Service resources within 10 minutes of alert, 33.04% were attended between 10 and 20 minutes and 23.35% were attended in over 20 minutes. The average turnout time for the Full-time station in Galway City was 2.05 minutes and for county retained stations was 5.56 minutes.

## ATHENRY FIRE STATION

Construction of the New Fire Station in Athenry continues with the project substantially complete and the building is now fully enclosed. Installation of services and remaining



siteworks are underway. It is anticipated that the station will be completed by the end of May 2024 subject to ESB connection going ahead as planned.

## LOUGHREA FIRE STATION

It is intended to proceed with public consultation in accordance with Part 8 of the Planning and Development Regulations for the proposed Loughrea Fire Station. It is hoped that a report will be submitted to the Loughrea Municipal District meeting in September for members consideration.

### BRIGADE MECHANICS WORKSHOP ATHENRY

Tender for Design Team is due to be issued in mid-May.

# HEADQUARTERS AND GALWAY CITY FIRE STATION

Preferred site identified and awaiting Chief Executive approval. There will be the initiation of a screening exercise in advance of any future development. Capital appraisal 99% complete and will be submitted to the National Directorate for Fire and Emergency Management once Chief Executive approval is available.

#### PREVENTION

The information in the following is based on the April figures. The Fire Authority received 21 Fire Safety Certificate applications and issued decisions on 20 applications. 8 Disability



Access Certificate applications were received, and decisions made on 8 applications. A total of 8 new licenses were issued and 27 inspections were conducted.

# GRANT AID FROM THE NATIONAL DIRECTORATE FOR FIRE & EMERGENCY MANAGEMENT

The National Directorate for Fire and Emergency Management are progressing to procure high volume pumps for flood and large fire situations. The pumps will be capable of pumping 8000 litres of water a minute to over 2 kms away and Galway Fire and Rescue Service have been allocated one of these units, the procurement process is underway with each unit costing approximately €1.2m euro and is fully funded by the NDFEM.

# TRAINING

Five new firefighter recruits successfully completed their initial training Firefighting Skills course which commenced on 8th April and lasted three weeks concluding on 26th April last. This brings the total number of new recruits who have completed their initial training thus far in 2024 to 12. These newly trained firefighters will be stationed at An Cheathrú Rua (x2), Gort (x2) and Cill Rónáin (x1) fire stations. It is planned to train a further five new recruit firefighters on a training course as soon as training places become available. These additional recruits will be stationed at Cill Rónáin (x2), Ballinasloe (x1), Portumna (x1) and Tuam (x1). Once completed this will bring the total number of newly recruited firefighters thus far in 2024 to 17 which already exceeds the average total annual intake of recruit firefighters.

Training was provided to members of the administration team in fire service headquarters on the use of the Gartan pay software system. Of particular relevance were updates in relation to changes required on the software system arising from the recommendations of the recent Workplace Relations Commission retained fire service agreement.

1 no. fulltime fire service officer attended the National Directorate For Fire & Emergency Management (NDFEM) "Managing Fire service Incidents – Module 1" training which took place in Sligo fire station.

1 no. fulltime fire service officer attended the NDFEM Effective Decision-Making training which took place at the Hydra Suite training centre in Clonmel fire station. The aim of this course was to enhance the ability of fire authorities to deliver efficient and effective fire and rescue services, by providing fire service officers with the opportunity to explore critical decision making relating to their role.

1 no. senior fire officer attended the NDFEM "Fire Safety Engineer" course. This was an intensive five-day training course which took place in Kilkenny.

1 no. fulltime firefighter attended the NDFEM "Fire Station Trainer" course which took place in Newbridge Fire Station from 15-19 April.



A number of training allocations were requested and granted on a number of National Directorate for Fire & Emergency Management's training courses scheduled to take place later in May. The courses in question being "Managing Fire Services Incident – Module 2" and "Fire Service Management 1" training courses.

# MAJOR EMERGENCY MANAGEMENT


A multi–Principal Response Agency Review commenced of the Upper Tier Control of Major Accident Hazards Site in Oranmore, with a Principal Response Agency & Relevant Stakeholder meeting early April and follow up exercise scheduled for the 23 May 2024. The Review will update the 2021 External Emergency Plan for the site, with a view to releasing a revised draft plan in June for Public Consultation.

During the Colas exercise, Galway Fire and Rescue Service hope to unveil our new Hazmat ROV Support Unit and remotely operated vehicle capability. This capability will significantly increase firefighter safety in high-risk areas including Control Of Major Accident Hazard sites. The capability has been funded by the National Directorate for Fire and Emergency Management and local Control Of Major Accident Hazard sites.



# NATIONAL UNIFIED RISK OPERATING PLATFORM (NUROP) PROJECT

The National Unified Risk Operating Platform project continues jointly with the Geographic Information System and Information Technology Section and the project team will be demonstrating its latest work at the Chief Fire Officer Association Conference in Trim on the 8<sup>th</sup>May 2024. In ground-breaking work, the system can now predict a risk score for every domestic residence (in conjunction with the Central Statistics Office) and every nondomestic premises in the country. This will facilitate targeted interventions which can also be mapped. Major emergency hazards have also been mapped for the entire country and will be factored into the new automated Area Risk Categorisation (ARC) process. Finally, a new pre-incident planning process has been developed to streamline the process.



## NUROP - DOMESTIC PREMISES PRIOITY ASSESSMENT TOOL

### CIVIL DEFENCE

Training for new members is currently ongoing in all 5 operational units across the county. Eight new members have enrolled in Civil Defence in April 2024. They have completed their Garda Vetting and will be inducted into the Unit over the coming weeks.

Emergency Medical Technician Practitioners have and are currently upskilling to the Pre-Hospital Emergency Care Council 2023 Clinical Practice Guidelines at the Civil Defence College in Roscrea. This upskilling must be completed by the end of 2024.

Civil Defence Boat and Drone Crews have been assisting with a request from An Garda Siochana with a search for a missing person in a local area. This assistance is coordinated by relevant Gardai and involves providing assistance to the Garda Water Unit, Mayo Civil Defence Drone crew and The Irish Coastguard. Civil Defence boat crews are utilising Sonar Technology on this task.

# ECONOMIC DEVELOPMENT & PLANNING

On 1st May 2024 the Management Team met with Denis Curran, Ricky Conneely and IDA Senior team to discuss economic development opportunities for County Galway. The focus of the meeting was strategic opportunities within Galway's Stratgic Economic Corridor.

# PLANNING ENFORCEMENT

We have welcomed a number of new staff to the planning Enforcement Team over the last number of months, and the dedication of the team has begun to show in the number of files being progressed.

A total of 110 enforcement complaints have been received between January and April 2024 and 95 files have been closed during this period.

The total number of Enforcement Notice severed between January and April was 25.

The number of cases listed for Court Hearing between April and June is 32.



## DEVELOPMENT MANAGEMENT

A total of 598 planning applications have been received between January and April 2024, of which 482 were e files representing 81% and 116 paper files representing 19% of files received.

# DEVELOPMENT CONTRIBUTION WAIVER SCHEME EXTENSION

Minister O Brien has received Government approval to extend the levy waiver and water charge refund arrangements beyond the dates indicated in previous Circular letter PL 04/2023 as follows:

- development works on qualifying housing units shall commence not later than **31** December 2024;

- the combined pre-existing waiver and refund arrangements shall continue in place for a further period of just over 5 months until **30 September 2024**;

- the water connection charge refund arrangements shall terminate on 30 September 2024 with the development levy waiver remaining in place on its own for the remaining 3 months of the year until **31 December 2024**;

- claims for the levy waiver shall be submitted by developers to local authorities not later than **28 February 2025**;

- requests for refunds of new water services connection charges shall be made to Uisce Éireann not later than **31 December 2024**.

The date for the completion of development works on qualifying houses under the scheme is extended from 31 December 2025 to **31 December 2026**. This completion date applies to all qualifying houses commenced since the introduction of the scheme, including those that have already commenced prior to the extension of the levy waiver and water charge refund arrangements as communicated in this Circular Letter.

In recognition of the fact that developers are required to submit "commencement notices" or "7-day notices" to the local authority, in accordance with the Building Control Regulations, prior to the commencement of works, the following should be noted –

- (i) "commencement notices" should be submitted to the local authority prior to the 14 day period preceding 31 December 2024 i.e. the latest date for submission will be 17 December 2024; and
- (ii) "7-day notices" should be submitted to the local authority not later than 24 December 2024.

A Commencement Notice or a 7 Day Notice may be filed electronically on the Building Control Management System or submitted manually to the local authority in the form for that purpose included in the Second Schedule to the Building Control Regulations (taking into account season specific local authority and NBCMSO leave arrangements).

It is an offence, under Section 16 the Building Control Act to commence works in the absence of a valid Commencement Notice or 7 Day Notice. In the case of new single unit developments where the developer has opted-out of the requirements for statutory certification under the Building Control Regulations, confirmation of commencement of works on site can be verified by way of visual drive-by inspection by suitable local authority technical personnel. Where this is not possible, the local authority should request relevant supporting documentation to substantiate the commencement date i.e., evidence of payment for pouring of foundations etc.

#### STRATEGIC POLICY COMMITTEE



The final meeting of the Planning SPC for the 2019-2024 period was held on the 30<sup>th</sup> April 2024. Topics discussed included review of County Development Plan, Local Area Plans, Residential Zoned land Tax & Waiver of Development Contributions Scheme.

The Chair, Cllr Mary Hoade and the other members thanked the Planning staff for all the work carried out during

the past 5 years including preparation of the new County Development Plan 2022-2028 and progressing a number of Local Area Plans with tight resources. The Director of Services thanked the Committee & Planning staff and outlined some of the work of Development Management e.g., numbers of planning applications processed etc.



#### FORWARD PLANNING

#### ATHENRY DRAFT LOCAL AREA PLAN 2024-2030

Athenry Local Area Plan 2024-2030 came into effect on 20/02/2024.

On 19/02/2024 – Minister of State for Local Government & Planning issued a "Notice of Intention to issue a Direction" on the Athenry Draft Local Area Plan 2024-2030. The Draft Direction concerns the zoning of five parcels of land in the town. CE Report on Submissions to Draft Ministerial Direction to the Athenry LAP 2024-2030 was submitted to Minister for Local Government & Planning; Members for Athenry MD and Prescribed Bodies on 03/04/2024. Still awaiting on Final Direction from Minister for Local Government & Planning.



# LOUGHREA DRAFT LOCAL AREA PLAN 2024-2030

## GORT

Gort received €250,000 in town and village funding thanks to an application by the Gort Town Team. The TRO in collaboration with the Town and Village administrators and the Gort Town team shall organise an information evening over the coming weeks to explain the eligible works under the scheme and encourage applicants from the eligible properties to avail of the streetscape enhancement funding. This scheme will avail of the services of a colour coordinator to advise applicants and will provide a real lift to the town centre, making it an attractive place.

Consultants have been appointed to work with the Gort Town Hall Management Committee to avail of the project development funding to get all necessary drawings and statutory consents in place for the renovation of the Gort Town Hall under the Historic Structure funding received from The Heritage Council. This project will ready the building for a capital funding application next year.

The Gort Public Realm Enhancement scheme is in its final stages of preparation for a Part 10 Planning application to An Bord Pleanála. It is expected the application will be submitted by quarter 3 2024.

#### TUAM

Tuam Town Hall and the Shambles projects are awaiting the decision of the Department of Rural and Community Developments CAT 1 Funding Call which is anticipated to be at the end of May.

An application for THRIVE funding was submitted to the Northwest Regional Assembly to fund the delivery of the design for the reuse of the Station House building as a remote working facility in partnership with Action Tuam and the lands surrounding Tuam Station Quarter to deliver a transportation hub for the Town. An announcement for the funding is expected at the end of May.

## BALLINASLOE

An application for THRIVE funding was submitted to the Northwest Regional Assembly to fund the delivery of a dedicated Town Centre First Plan focusing on the historic core and Fair Green. An announcement for the funding is expected at the end of May.

## URDF CALL 3 - VACANCY AND DERELICTION

Valuers appointed to the three qualifying towns of Ballinasloe, Tuam and Oranmore with 20 properties initially identified as candidate properties that are either vacant or derelict.

Ownership is being determined in many cases and engagement will be pursued with these owners to assist in having these properties re occupied.



#### HERITAGE OFFICE

#### GALWAY COUNTY HERITAGE & BIODIVERSITY PLAN 2024 - 2030



Galway County Council Heritage Office and Galway County Council Biodiversity Office undertook public consultation with regards to the development of a new Heritage & Biodiversity Plan for the county of Galway from 2024 to 2030. These well attended events were held in Oranmore, Leitir Meallain, Abbey, Milltown, Ballygar, Oughterard and Bearnaderg.

These events were held in partnership with local heritage and biodiversity groups.

In addition to this the Heritage and Biodiversity Offices commissioned "The Wishing Tree Project" facilitated by artist Maria Hitchcox. The "Wishing Tree Project" consisted of a series of art facilitation workshops. The workshops targeted primary school children in Inishbofin.





TY students in Seamount College, Kinvara the Traveller Community in Tuam, people with

intellectual disabilities in The Brothers of Charity, Clarinbridge and Mountbellew Active Retirement. This initiative resulted in

a fantastically diverse collection of viewpoints and perspectives, which were well outside our expectations.







Complimentary to this, a large number of written submissions were received. The feedback from the workshops and submissions is currently being analysed and it will contribute to the development a Heritage and Biodiversity Plan that reflects the needs and priorities of our cultural, built and natural heritage as voiced by a diverse cross-section of the people of County Galway.



#### STAKEHOLDER FORUM: MANAGING VEGETATION ON HISTORIC MASONRY

The Irish Walled Towns Network & Traditional Farm Buildings Grant Scheme held a stakeholders' forum with regards to managing vegetation on historic masonry in Athenry on 11<sup>th</sup> April. Over 60 people travelled from all parts of the country to attend this event. The Heritage Office of Galway County Council provided assistance to the Heritage Council in hosting and promoting the event. Martin Coombes Biogeomorphologist, Oxford Resilient Buildings & Landscapes Lab Co-author, Ivy on Walls Research Report, Historic England spoke about "Ivy on Walls and other stories". This was followed by three case studies one on the Lea Castle Project by Fiona McGowan Consultant Ecologist, another entitled" Knockboy Church & Graveyard" was presented by Tom Pollard Stone Mason & GLAS and Farmer; the



third case study dealt with recent works at Dunmore Caves, Co Kilkenny and this talk was delivered by Faith Wilson Consultant Ecologist.



This was followed by breakout discussion groups and a visit to Athenry Walls to discuss the works being undertaken there and how vegetation on the walls is being undertaken.

# TOUR HIGHLIGHTS IMPORTANCE OF EAST GALWAY MONUMENTS AND HERITAGE SITES

History enthusiasts and community group representatives from across County Galway have participated in whistlestop bus tour of some of East Galway's most intriguing built heritage sites.

Galway Community Archaeology Project and Galway County Council's Heritage Office hosted the



free bus tour of Kilboght Church and Graveyard, Abbeygormican and St. Kerrill's Abbey in Gurteen as part of International Day for Monuments and Sites 2024.

Gurteen Community Council, Kilboght Graveyard Heritage Group and Abbeygormican Cemetery Group have each prepared conservation management plans and undertaken conservation works at the historic sites through the Community Monuments Fund, which is administered by Galway County Council on behalf of The National Monuments Service.

Participants of the day tour first visited the Abbeygormican, an Augustinian House founded by the Cormicans in the 12th Century. What stands today is the chancel wall and transept chapel, now conserved thanks to ongoing work by the graveyard committee in securing funding. An artist's impression of what Abbeygormican may have looked like was also shown to allow the group to visualise this important site. The group has also carried out the



Digital Recording of the Graveyard, funded by Galway Rural Development and supported by Galway County Council and The Heritage Council.

Next up was Kilboght Church, Graveyard and Mausoleum, which also has seen a transformation with the removal of ivy and stabilisation of the church and The Blake Mausoleum. Peggy Doherty told the group about the years of ongoing struggle for the community to maintain this rare and sensitive site. Dr Christy Cunniffe and Dominic Delany were on site to guide the visitors and point out architectural fragments used as grave markers, medieval tool marks on the water font and the outline of the original medieval parish church and later extensions. Mike Herwood, Galway Stone Design was also on hand to demonstrate the skills of the tradesmen who carried out the works at Kilboght 2023.

The touring group were treated to an enlightening talk by Pat Roberts, Ecologist with MKO Ltd on his involvement with each conservation project, and the need to engage with professional services in advance of any works at an archaeological site or monument, particularly when overgrowth or ivy is involved.

The final stop of the day was at St Kerrill's Abbey in Gurteen, also known as



Cloonkeenkerrill, where Martina Donnellan highlighted St Kerrills significance within the community, and informed the group about the folklore and traditions of the church and graveyard. An effigy to Bishop O'Kelly, A cat-o-mount on a Burke tomb and several medieval architectural features including an ogee headed window were highlighted.

Galway and Mayo ICAN Group members met in Killererin on 17<sup>th</sup> April. During the first part of the day, each group gave an account of their activities, events, and projects. The range and richness of the work happening across the network is incredible, from heritage and castle trails in Skehana and Woodlawn, conservation Managment Plan of Moylough

Castle, letter collections in Milltown, the gathering of songs and stories in Oughterard, and the restoration of a telephone kiosk in Abbey to the Minor Placenames of Baile Chláir, as well as heritage research, audits, biodiversity projects in Maigh Cuillin and Killererin and the planned transcription of a 1930s GAA Minute Book. And that's just a flavour of the work that is being carried out.

Lots of the heritage groups collaborate with others, whether schools, sports clubs, Tidy Towns, Mens Sheds, community groups or organisations and funders to achieve their aims. The second part of the day was devoted to consultation on the County Galway Heritage & Biodiversity Plan and a discussion on the upgrade of the Galway websites (Galway Community Heritage). The final part of the day involved a trip to Killererin Graveyard (one of three in the parish) to see the graves, the remains of the medieval church and the information boards that form part of the Graveyard Survey project.


#### BIODIVERSITY

#### LOCAL BIODIVERSITY ACTION FUND PROJECTS

The National Parks and Wildlife Service (NPWS) of the Department of Housing, Local Government and Heritage has agreed to grant €107,130 for a series of 12 projects biodiversity projects around the county this year. This funding will see continued work on invasive alien species through mapping and eradication, which represent a serious threat to the habitats in the county. This funding stream will also see work will also be carried out on restoring a roost for the lesser horseshoe bat near Belclare, studies on the conservation status of Mayflies and outreach and community engagement projects relating to pollinators, barn owls and the biodiversity of the Shannon Callows. ## CLIMATE ACTION PLAN

One of the priority actions identified in the Climate Action Plan under the Community and Partnerships Theme is Action CP 1.2: *Training, information and support programme for individuals, community groups and community event organisers*.



As part of the implementation of this action, the Climate Action Unit participated in the Green Recovery Group Energy Masterplan Dissemination Sessions which are scheduled to be held in each Municipal Distict. Sessions were carried out in Tuam, Ballindereen, Laurencetown and Lackagh and there will be a further session in Maigh Cuilinn. The sessions included presentations from SEAI, Housing Section, Climate Unit and Community Section.





The Climate Unit also participated in an Information Event on Business, Energy and Housing Supports in Clifden which included presentations from SEAI, Housing Section, Climate Unit, Community, Planning and the Local Enterprise Office.

## COMMUNITY CLIMATE ACTION FUND

The Community Climate Action Fund closed on February 29<sup>th</sup> with a high level of applications received from the community and voluntary sector. There were 56 applications in total and projects included building upgrades, solar panels, bike repair stations, swap shops and community gardens. An internal evaluation committee is currently assessing the applications and the recommended applications will be sent to DECC for approval.

#### INTERNAL ENERGY USE

Work is ongoing to attain ISO 50001 energy management standard within the organisation to optimise energy use and attain our 2030 targets. A tender for an automated Data Collection System was published on the 11<sup>th</sup> of April and submissions are due by the 11<sup>th</sup> of May. Outputs from this system will support analysis of energy use within the organisation.

#### COMMUNITY AWARENESS DAY

Galway County Council attended the Kinvara Farmers market with an information stand on food waste prevention and recycling. 6th class from the local primary school also attended for the presentation for a question-and-answer session.

#### CLARINBRIDGE CÁIRDE CLUB

The Environmental Awareness Officer gave a presentation to 30 members of the Clarinbridge Cáirde Club on Food Waste Management and Recycling.

#### NATIONAL SPRING CLEAN



Registration concluded for National Spring Clean 2024 with 200 groups or individuals registered. Support continues for cleanups through 2024.

#### ANTI-DOG FOULING CAMPAIGN



During the month of April Galway County Council worked in partnership with the Tidy Towns Groups in An Spidéal, Bearna, Cleggan, Clifden and Roundstone in highlighting the Dog fouling issue and encouraging the public to clean up after their dog and be responsible dog owners.

## **BATHING WATERS**



As part of Biodiversity Week, Galway County Council's Environment Section are hosting a Bilingual Seashore Event at Trá an Dóilín on Friday, 24<sup>th</sup> May 2024. This is one of our Blue Flag beaches and it is hoped to connect the local community with nature and promote the biodiversity of Trá an Dóilin's coral beach and crystal-clear waters. The event will include a Seashore Bioblitz, a Scavenger Hunt and Beach Clean.

#### WORKSHOP HELD AN TRÁ INIS OIRR AND AN TRÁ MHÓR, INDREABHAN



A workshop held by Ecologist Marie Louise Heffernan, Aster Environmental Consultants, as part of our educational awareness programme, was held on our Blue Flag beach at An Trá, Inis Oirr on the 26th of April 2024. All the local school children from the Island participated in the workshop and learned all about the local beach, the rocks and marine litter and how it impacts on the beach.

Also, Pupils from Colaiste Cholmcille, Indreabhán participated in the ecology workshop as part of our education awareness programme, at our blue flag beach at An Trá Mhór, Indreabhan during April 2024.











## WASTE MANAGEMENT

#### WASTE/AIR MANAGEMENT AND ENFORCEMENT

Inspections of premises under Producer Responsibility Initiatives were continued during April.

#### JOINT INSPECTIONS

Two vehicle checkpoints were held with the Gardai during April. One in Maigh Cuilinn and one in Na Forbacha. Vehicles capable of transporting waste illegally are stopped and checked during checkpoints to detect illegal collectors and prevent illegal dumping across the county. Over 40 vehicles were stopped and close to 20 were inspected on the day. The campaign was highlighted on TG4 and in the Connacht Tribune.







## VALIDATION OF ANNUAL WASTE RETURNS

Each year, all permitted waste collectors and facilities/certificate of registrations must submit information on the tonnage and types of waste transported/accepted for the previous year to the NWCPO by the 28th of February. These figures are then validated by Enforcement Officers. Of the 32 permitted waste collectors and 72 waste permitted facilities/COR in Galway, 8 operators had failed to submit figures before the deadline. These operators were issued with Fixed Payment Notice Fines for non-submission. Enforcement officers can access these figures from April when the validating of Annual Returns figures takes place over the months.

## WASTE PRESENTATION BY LAW ENFORCEMENT

Following on from the Waste Presentation Bye Law inspections carried out in March, Warning Letters and Fixed Payment Notices were issued to Householders for noncompliances on the day.

#### COURT FILES

Three files were submitted to the Law Department to initiate legal proceedings during April. Two of the cases are for an offence under Section 32 of the Waste Management Act. This is where an individual is causing environmental pollution by holding, sorting or storing waste. The other case is for a Section 32 offence and for non-compliance with a Section 55 notice. Section 55 is a legal notice issued to an individual directing them to carry out certain measures within a specified timeframe to limit and remediate environmental pollution.

#### COURT ATTENDANCE

There was one court case heard in April. It was a prosecution for a failure to comply with a Section 55 notice to clear a site of End-of-Life Vehicles. It had previously been adjourned to give the offender a chance to clear the site. When heard in April the site was nearly cleared and it was adjourned again until May to allow the site to be fully cleared.

## CONAMARA MUNICIPAL DISTRICT UPDATE

#### UPDATE ON ACTIVITIES FOR CONAMARA - MAY 2024

- The Restoration Improvement Works and Restoration Maintenance Works has been awarded and works have commenced. A total of 120 sections of roads throughout Conamara MD will be resurfaced.
- An application for funding regarding for Inishbofin, Inis Mor, Inis Meain and Inis Oir has been submitted to the Department of Rural Community Development. Substantial funding was granted in 2023 and a decision on 2024 funding is expected shortly.



- An allocation of €30,000 has been granted by the Department of Transport to progress a Strategic Infrastructure Scheme at Cuan na Loinge to address flooding of the main road into this area.
- Safety Improvement Works allocation of €35,000 has been granted to refurbish the traffic signal heads and push button units in Maigh Cuilinn.
- Climate Change Projects €305,000 (4 projects) has been allocated.
- Outdoor staff principal concern is the undertaking of the roads programme.
- Community Wardens 3 positions dealing with illegal dumping, parking enforcement, ringbuoy inspections.
- Town and Village Maintenance substantially done by direct staff.
- Piers & Harbours- Direct labour projects ongoing under marine infrastructure scheme.
- Operation & Maintenance of Public Beaches- Summer ready- preparing for summer 2024.
