

# Financial Support to assist businesses in the Hospitality and Retail Sectors

Power Up grant of €4,000 is available to businesses in the hospitality and retail sectors.

**Register before Friday 8 November.**

Local Authorities are now emailing businesses who may be eligible for the Power Up grant.

The email includes details on how to register. Don't delay with registering, the Power Up registration Portal is open for a limited time in order to get payments to businesses before the end of the year.

Registering is similar to ICOB registration and is quick and easy. Please go to [mycoco.ie/powerup](http://mycoco.ie/powerup) for further information.

If you have not received an email and think you may be eligible please contact your Local Revenue Collector.

## What is the Power Up grant?

The Government announced the Power Up grant as part of Budget 25 for businesses in the Retail and Hospitality sector. The Power Up grant has a budget of €170 million and the grant to eligible businesses will be €4,000.

## Who is eligible for Power Up?

There are two types of qualifying business:

- A business that received the second payment of ICOB and continues to meet the ICOB criteria
- Businesses in the hospitality and retail sector that did not have a rates bill in 2023 may qualify if they meet the criteria. Those businesses should check with their local authority to check eligibility once the scheme goes live.

Tá Údarás Áitiúla ag seoladh ríomhphoist anois chuig gnólachtaí a d'fhéadfadh a bheith incháilithe don deontas Power Up.

Tá sonraí sa ríomhphost maidir le conas clárú. Ná cuir clárú siar, níl an Tairseach clárúcháin Power Up oscailte ach ar feadh tréimhse teoranta ionas gur féidir íocaíochtaí a chur ar fáil do ghnólachtaí roimh dheireadh na bliana.

Tá clárú cosúil leis an gclárú ICOB (costais mhéadaithe gnó) agus tá sé tapa agus éasca. Téigh chuig [mycoco.ie/powerup](https://mycoco.ie/powerup) chun tuilleadh eolais a fháil.

Mura bhfuil ríomhphost faighte agat agus má cheapann tú go bhfuil tú incháilithe, déan teagmháil le d'Údarás Áitiúil, le do thoil.

## Cad é an deontas Power Up?

D'fhógair an Rialtas an deontas Power Up mar chuid de Bhuiséad 25 do ghnólachtaí san earnáil Miondíola agus Fáilteachais. Tá buiséad de €170 milliún ag an deontas Power Up agus beidh an deontas do ghnólachtaí incháilithe cothrom le €4,000.

## Cé atá incháilithe le haghaidh Power Up?

Tá dhá chineál gnó incháilithe ann:

- Gnólacht a fuair an dara híocaíocht ICOB agus a leanann de bheith incháilithe le haghaidh ICOB
- Féadfaidh gnólachtaí san earnáil fáilteachais agus miondíola nach raibh bille rátaí acu in 2023 cáiliú má shásaíonn siad na critéir. Ba cheart do na gnólachtaí sin seiceáil lena n-údarás áitiúil chun incháilitheacht a mheas a luaithe a chuirtear an scéim beo.
