Message from the Chairperson of the County Galway Joint Policing Committee

As Chairperson of the County Galway Joint Policing Committee, I welcome the publication of the 2019 Annual Report. The Report details the work of the Committee in delivering on the objectives of the Strategic Plan 2015 – 2021 and is an important means of communicating the role and work of the Committee.

Throughout the past year, the Joint Policing Committee (JPC) continued to play a valuable role in providing strategic linkages and strong channels of communication between An Garda Síochána, Galway County Council and the wider community in matters of policing and safety.

The JPC also provided a level of local democratic oversight of the Gardaí's work within County Galway through the forum it provides to elected representatives and those representing community and voluntary organisations to raise matters of local concern.

The JPC convened on four occasions during 2019 including its Annual Public Meeting held on Monday 4th November 2019 in the Ard Rí House Hotel, Tuam. Public meetings offer an excellent opportunity for local communities to participate and engage in relation to general policing matters affecting the policing of the County of Galway and in particular policing matters affecting their areas.

Significant progress has been made on achieving our strategic objectives and I would like to thank the members of the JPC and its Sub Committees for their work during 2019.

INTRODUCTION

Section 35 of Garda Síochána Act, 2005 provides for the establishment of Joint Policing Committees (JPC). The County Galway Joint Policing Committee was established in 2009.

The County Galway JPC committee comprises 35 members representing Galway County Council (elected members and officials), members of the Oireachtas in the county, An Garda Síochána and the Community and Voluntary sector.

The JPC's function is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of Galway County Council's administrative area, and to keep under review:

- > the levels and patterns of crime, disorder and anti-social behavior in that area, and
- > the factors underlying and contributing to the levels of crime, disorder and antisocial behavior in the area

This Annual Report 2019 outlines how the County Galway Joint Policing Committee carried out its function for this period in compliance with section 36(2) of the Garda Síochána Act 2005 and in accordance with the revised Joint Policing Committee guidelines of 2014.

The following are the JPC Sub-Committees as agreed by the County Galway Joint Policing Committee during 2019 to progress the strategic objectives of the 6 Year JPC Strategic Plan:

Illegal Dumping & Litter Awareness Sub-Committee

To Support and Promote awareness of litter management plans and initiatives, the negative impact of illegal dumping and littering and to promote and advise the public on the importance of reporting incidents of illegal dumping and littering.

Education & Awareness - School Programme AND Crime Prevention/Personal Safety Sub-Committee

To promote, Education and Awareness Programmes for schools on personal safety, road safety, bullying, illegal substance abuse, and underage drinking.

To increase awareness of crime prevention for communities, business, house holders and individuals.

JOINT POLICING COMMITTEE WORK PROGRAMME

A six-year Strategic Plan was developed for the County Galway JPC for the period 2015-2021 which contains four high-priority objectives contributing to the improved safety and quality of life in the community.

- 1. Illegal Dumping and Littering
- 2. Education and Awareness Schools Progamme
- 3. Crime Prevention/Personal Safety
- 4. Communication Strategy

The 2019 Work Plan was based on the current Guidelines and Code of Practice which apply to JPCs and the associated strategies and expected outcomes set out in the six-year Strategic Plan.

ITEM 2: KEY HIGHLIGHTS AND ACHIEVEMENTS 2019

Achievement 1/2019

During 2019, the Illegal Dumping & Littering Sub-Committee continued to address the issue of illegal dumping.

The Sub Committee continued to work collaboratively with Supermacs Fast Food restaurant on 'Glan agus Glas' (Clean and Green) initiative. The initiative by Supermacs aimed to introduce the use of 100% recyclable cups; paper straws to replace plastic straws; biodegradable burger wrapping and the introduction of dispensers for sachets and napkins.

To support Galway County Council's "A Cleaner, Greener, Galway", a new anti-dumping awareness campaign 'It's Not in Our Nature — Is it in Yours?' #stopandumpail #stopthedumping was rolled out for the Connacht Ulster Waste Region to create awareness around illegal dumping.

The aim of this collective and shared campaign is to generate maximum awareness amongst the people of Galway and surround areas with a view to ultimately eliminating litter and illegal dumping from Galway's environment and eradicating the need for clean ups. Thus creating "a cleaner, greener, Galway" for everyone to enjoy.



Achievement 2/2019

In accordance with the strategy to promote and advise the public of the importance of road safety, the Education & Awareness Sub Committee/Crime Prevention & Personal Safety in conjunction with An Garda Siochána and the Council's Road Safety Officer, in line with the Road Safety Plan 2017-2020, assisted in highlighting road safety awareness to all the importance of being visible at all times through its many programmes held throughout the year to include the 'National Be Safe Be Seen Day' campaign.

The aim of the event was to encourage all pupils to wear their high visibility vests when walking or cycling to school.

Scoil An Chroí Naofa, Ballinasloe, took part in the initiative and on Thursday 10th October 2019, pupils in 1st Class were given a Road Safety Awareness talk by the Council's Road

Safety Officer, Ms. Deirdre Caulfield, and Garda Inspector Conor Madden. The topics of walking, cycling, use of seat belts, travelling by car and bus was included. The pupils also took part in a walk from the school around the town wearing their high visibility vests, courtesy of the Road Safety Authority. Ms. Deirdre Caulfield, Road Safety Officer, advised the pupils on the Safe Cross Code – STOP. WAIT. LOOK. LISTEN! It is hoped that by highlighting road safety awareness to the young children, that they will see the importance of being visible at all times.








Achievement 3/2019

Patrick Conway, Garda National Crime Prevention Unit, on the functions and role of the Galway County Joint Policing Committee including Best Practice, Procedures for Tabling Questions, Communications and the role of the Steering Group; following which he invited questions from the members.



Achievement 4/2019

The sub-committees of the JPC (*Illegal Dumping & Litter Awareness Sub-Committee, Education & Awareness – School Programme and Crime Prevention/Personal Safety Sub-Committee*), continued in 2019 to deliver on the strategic objectives of the Strategic Plan 2015 – 2021.

Questions to be considered by the Joint Policing Committee were also invited from the public prior to the meeting on general policing matters affecting the policing of the County of Galway.

Some of the following topics were also raised and discussed at the Meeting:

- Crime in the area and the necessity for the installation of CCTV cameras at strategic locations to assist in crime detection/prevention.
- The need additional Garda resources especially in rural Garda Stations.
- Anti-social behaviour/vandalism in local park.
- Misuse of illegal substances and drug epidemic.
- Traffic speed on village and towns streets and on approach to N84.
- The importance of wearing hi-vis jackets.
- Illegal dumping.

CIIr. Jim Cuddy, Chairperson of the JPC, thanked all who attended the meeting and who raised concerns/issues and acknowledged that the JPC Public meetings provide an excellent opportunity for the public to engage with the local authority and the Gardaí in matters relating to the general policing of the county.
