16th Oct. '96. From Sir C. Cameron furnishing the results of analysis of 15 specimens of tea received, and stating that the samples vary a little as might be expected, no two sample chests of tea giving exactly identical results to analysis. They, on the whole, contain slightly more soluble matter than the contract sample.
Also that he has examined two specimens of butter received. They were free from foreign
